What is this product?

Type
This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

Objectives

The objective of the sub-fund is to achieve a return equal to or above that of the bond and credit markets, having an investment grade rating, while allowing investors to contribute to the energy transition. The management policy will also take into account environmental, social and good governance (ESG) criteria in addition to conventional financial criteria for stock selection.

LUX-BOND GREEN invests:

- mainly in green bonds in accordance with the Bloomberg and/or Climate Bonds Initiative selection criteria, which are investment grade and denominated in the respective currencies of OECD member countries;

incidentally in other bond securities, total investments in noninvestment grade bonds and non-rated bonds are limited to a maximum of 10% of net assets; in other financial instruments provided for by the investment restrictions, including cash, MIFs and/or UCITS/other bond and/or money market UCIs.

The assets of the sub-fund may include, for a minority part, securities of issuers domiciled and/or listed in emerging countries as well as UCIs/UCITS and/ or other authorised instruments in accordance with point III. A) 1.1. of the prospectus on the emerging market-oriented.

Investments in UCITS/other UCIs will be limited in total to a maximum of 10% of the net assets of the sub-fund.

For the purposes of good management and /or hedging, the subfund may use all derivative financial instruments (such as forex and/or other currency derivatives/exchange rates used in a purpose of good management and/or hedging of currency risk, etc.) and other techniques/instruments set out in the Investment Restrictions in the

prospectus and within the limits provided.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

The sub-fund is particularly suitable for an investor with a conservative risk profile, seeking a global bond return with limited volatility. The class M is open to investors whose shares are subscribed under a discretionary management mandate exercised by a financial intermediary.

Other information

Depositary: Banque et Caisse d'Epargne de l'Etat, Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one subfund do not affect the other sub-funds.



What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

What happens if Spuerkeess Asset Management S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque et Caisse d'Epargne de l'Etat, Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 10,000 EUR is invested

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

You should be prepared to stay invested for 5 years. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
