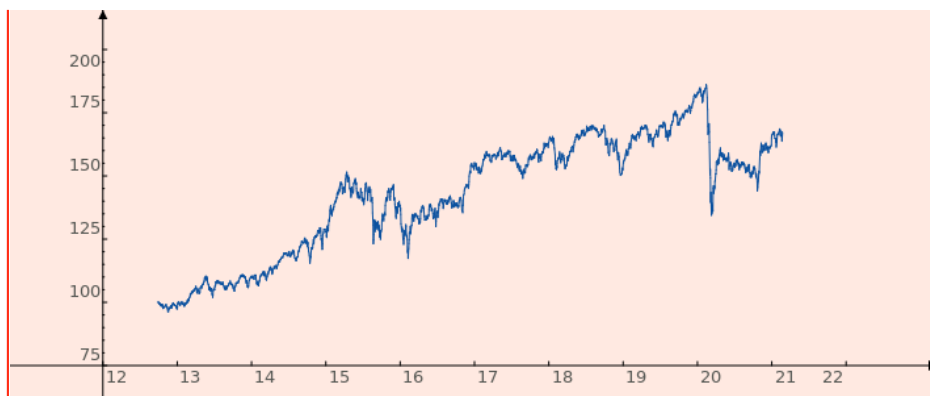

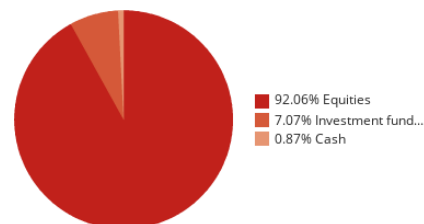

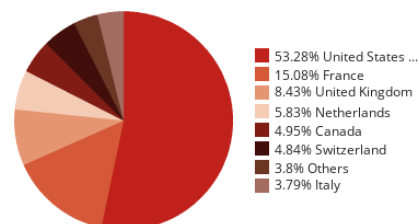

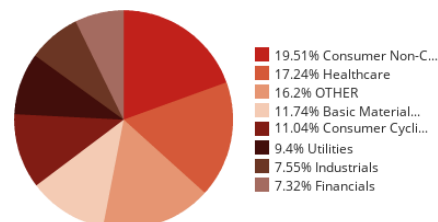
INVESTMENT ALLOCATION AS PER 29/01/2021
